- f. Should a credit availability be granted, all decisions with respect to the extension, continuation or termination shall be at the sole discretion of Glenn Zanders Sporting Goods.
- g. This agreement applies to any and all invoices on our account including future dated invoices of the applicant before or after date until revoked in writing by either party and a new credit agreement is made. If the agreement is revoked in writing, these terms shall still apply to any purchases made prior to the date of revocation.
- h. I(we) agree that in the event any portion of this account shall become delinquent any and all invoices on our account, including future dated invoices, shall at the sole discretion of Glenn Zanders Sporting Goods, become due and payable immediately.
- i. If all or any portion of any account is referred to an attorney or collection agency, applicant will pay all attorney's fees and collection expenses incurred by Glenn Zanders Sporting Goods.
- j.
